Please read the Official Rules and Regulations (“Official Rules”) of the 2023 *You Save, We Donate* Sweepstakes (“Sweepstakes”). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE OR IMPROVE YOUR CHANCE OF WINNING. THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.

1. SWEEPSTAKES DESCRIPTION: The Sweepstakes begins on Tuesday, September 5, 2023, at 12:00 A.M. Eastern Time and ends on Wednesday, November 22, 2023, at 9:00 A.M. Eastern Time (“Sweepstakes Period”). Each week of the Sweepstakes Period will be a separate Sweepstakes Week and each Sweepstakes Week begins on the Tuesday of that Sweepstakes Week at 12:00:00 A.M. Eastern Time and ends the following Friday at 2:00 P.M. Eastern Time in accordance with the Sweepstakes Schedule below.

2. ELIGIBILITY: The Sweepstakes is open only to legal residents of the State of New Jersey at least eighteen years of age and an NJNG customer at time of entry (“Entrant”). Entrant must be an NJNG residential customer in good standing during the entire Sweepstakes Period and at the time of the drawing.

Employees, directors and officers and their immediate families (spouses and siblings, parents and children and their spouses) and household members of New Jersey Natural Gas Company and its parent company, subsidiaries and affiliates and companies involved in the implementation and execution of the Sweepstakes (collectively the “Sweepstakes Entities”) are not eligible. The Sweepstakes is void outside of the State of New Jersey and where prohibited. The Sweepstakes may only be entered in or from the State of New Jersey, and entries originating from any other jurisdiction are not eligible for entry. All federal, state and local laws and regulations apply.

3. SPONSOR: New Jersey Natural Gas Company, 1415 Wyckoff Road, P.O. Box 1464, Wall, NJ 07719 (the “Sponsor”)
4. AGREEMENT TO THE OFFICIAL RULES: By participating in the Sweepstakes, each Entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes. Winning any prize is contingent upon fulfilling all requirements set forth herein.
5. HOW TO ENTER: During the Sweepstakes Period, Sponsor will post an Energy-Savings Post to its Facebook page located at facebook.com/NewJerseyNaturalGas and its Instagram page located at Instagram @njnglife (“Sponsor’s Pages”) in accordance with the Sweepstakes Schedule set forth in Section 1.

To enter the Sweepstakes, provide a response (“Sweepstakes Response”) to the Energy-Saving Post by:

- Posting a comment responding to the Energy-Savings Post on Sponsor’s Facebook post;
- Posting a comment responding to the Energy-Savings Post featured on Sponsor’s Instagram page;
- Posting a response to Energy-Savings poll featured on Instagram stories on Sponsor’s Instagram page; or
- Posting a response to an Energy-Savings Instagram story on Sponsor’s Instagram page.

By providing a Sweepstakes Response, you will be automatically entered into the Sweepstakes. Limit one (1) Entry per person per NJNG account per Sweepstakes Week regardless of method of entry. In the event that multiple entries are received for the same NJNG account, the account holder at the time of entry will be considered the entrant.

All entry information shall be collectively referred to herein as the “Entries” or each as an “Entry.” Entries must comply with the Guidelines and Restrictions defined below.

If you choose to enter via Facebook, you must be a registered user of Facebook and comply with the Terms of Service found at <https://www.facebook.com/terms.php> in order to enter the Sweepstakes. All terms and conditions of Facebook.com apply. To the extent of any conflict between these Official

If you choose to enter via Instagram, you must be a registered user of Instagram and comply with the Terms of Use found at <https://help.instagram.com/581066165581870> in order to enter the Sweepstakes. All terms and conditions of Instagram.com apply. To the extent of any conflict between these Official Rules and the Instagram's Terms of Use, these Official Rules will apply.

No automated entry devices and/or programs permitted. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Proof of submission will not be deemed to be proof of receipt by Sponsor. If you choose to enter using your mobile device, standard data fees may apply. You should consult your wireless service provider's pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier. You should also check your device's features for capabilities and check the device manual for specific use instructions.

Entry Guidelines and Restrictions: Entries become the property of Sponsor and will not be acknowledged or returned. 6. **WINNER SELECTION:** On or about the Friday following each Sweepstakes Week, two (2) winners will be selected in a random drawing (each a "Sweepstakes Week Drawing") from all the eligible Entries submitted for that Sweepstakes Week's Energy Saving Post for a total of twenty-four (24) winners throughout the Sweepstakes Period. Odds of winning depend on the number of eligible entries received for each Sweepstakes Week Drawing. Drawing will be conducted by Sponsor.
7. **PRIZES.** Each winner will receive a \$100 check. Total approximate retail value of all prizes combined: \$2,400. Prizes are non-transferable. No substitutions or cash redemptions. In the case of unavailability of any prize, Sponsor reserves the right to substitute a prize of equal or greater value. All taxes and unspecified expenses are the responsibility of winners. Limit one (1) prize per NJNG account.
8. **DONATION.** During the Sweepstakes Period, for each Sweepstakes Response to each Energy Saving Post, NJNG will donate \$5 and for each "like" on our Facebook/Instagram post or Facebook/Instagram Story, NJNG will donate \$2.50 up to a total of \$10,000 ("Donation Amount"). The Donation Amount

will be distributed to the Interfaith Food Pantry and Fulfill with 2/3 of the Donation Amount given to Fulfill and 1/3 to Interfaith Food Pantry. This Sweepstakes is in no way sponsored, endorsed or administered by or associated with Fulfill or Interfaith Food Pantry.

9. NOTIFICATION: Potential winners will be notified on or about the Friday following each Sweepstakes Week. Potential winners will be notified through a post to Facebook and Instagram requesting potential winners to private message NJNG to provide their contact information, or via a private message associated with their respective Facebook and/or Instagram account. Potential winner will be required to respond to Sponsor within five (5) business days of notification in order to claim his or her prize. Potential winners may be required to sign and return, where legal, an Affidavit or Declaration of Eligibility and Liability/Publicity Release (“Affidavit/Release”) within five (5) business days of prize notification. If any potential winner cannot be contacted within five (5) business days of first notification attempt, if any prize or prize notification is returned as undeliverable, if any potential winner rejects his/her prize or in the event of noncompliance with these Sweepstakes rules and requirements, such prize will be forfeited, and an alternate winner will be selected from all remaining eligible entries (time-permitting). Upon prize forfeiture, no compensation will be given. Delivery of prizes via USPS Certified Mail requires a street address (no P.O. Boxes). A potential winner may be required to show proof of being the authorized NJNG account holder.

If the Sponsor decides to reconvene the Sweepstakes after a suspension, the determination of the prizewinner will be made from among all eligible, non-suspect Entries received as of the date of the suspension, as Sponsor determines in its sole discretion.
