18.9-Megawatt Project Turns Underutilized Space into Clean Energy

Wall, NJ, October 1, 2024 – On Wednesday, October 9, 2024, NJR Clean Energy Ventures (CEV) and CEP Renewables – two leaders in the solar marketplace – will host a ribbon-cutting ceremony to celebrate the completion of the Foul Rift solar project. The 18.9-megawatt solar array is constructed atop a brownfield using innovative fixed-tilt, bifacial modules with solar cells that capture the sun’s rays on both sides of the module. The clean energy produced will help meet the annual power demand of approximately 3,390 households.
