

NJNG “LOVE TO SAVE. LOVE THE SHORE” SWEEPSTAKES OFFICIAL RULES

Please read the Official Rules and Regulations (“Official Rules”) of the New Jersey Natural Gas “Love to Save. Love the Shore” Sweepstakes (“Sweepstakes”). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE OR IMPROVE YOUR CHANCE OF WINNING. THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.

SWEEPSTAKES DESCRIPTION: The Sweepstakes begins at 8:00 a.m. New Jersey Time on Monday, April 1, 2013 and ends at 4:00 p.m. New Jersey Time on Friday, May 31, 2013 (“Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open only to customers of New Jersey Natural Gas Company (“NJNG”) who are legal residents of the State of New Jersey at least eighteen years of age and who have an active NJNG account on the date of the Sweepstakes entry submission (“Entrant”). Employees, directors and officers and their immediate families (spouses and siblings, parents and children and their spouses) and household members of NJNG and its parent company, subsidiaries and affiliates and companies involved in the implementation and execution of the Sweepstakes (collectively the “Sweepstakes Entities”) are not eligible. The Sweepstakes is void where prohibited.

AGREEMENT TO THE OFFICIAL RULES: By participating in the Sweepstakes, each Entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes. Winning any prize is contingent upon fulfilling all requirements set forth herein.

HOW TO ENTER: To enter the Sweepstakes, visit the NJNG fan page on Facebook, then “Like Us,” download the application that will enable you to enter the Sweepstakes, and fill out and submit the application. Alternatively, you may mail a hand-printed 3” x 5” postcard with your name, address, NJNG account number, e-mail address (if you have one) and telephone number to NJNG “Love to Save. Love the Shore” Sweepstakes, New Jersey Natural Gas Company, 1415 Wyckoff Road, P.O. Box 1464, Wall, NJ 07719. Only one Entry per active NJNG account number. In the event more than one (1) Entry is received from any one account number, the first Entry processed will be considered the only valid Entry received for that Entry Period. In the event of a dispute, Entries will be deemed made by the authorized account holder of the NJNG account number submitted

at the time of Entry. The authorized account holder is the person who is assigned to the NJNG account number by NJNG. The potential winner may be required to show proof of being the authorized account holder. No mechanical reproductions permitted. Sponsor is not liable for lost, late, misdirected, or corrupted Entries whether due to a technical error or otherwise. Entries become the property of Sponsor and will not be acknowledged or returned.

BY SUBMITTING AN ENTRY, THE ENTRANT IS PROVIDING INFORMATION TO SPONSOR AND NOT TO FACEBOOK.

RIGHTS HAVE NOT BEEN OBTAINED FROM FACEBOOK AND FACEBOOK IS NOT ENDORSING THE SWEEPSTAKES, NJNG, OR ITS PRODUCTS OR SERVICES.

WINNER SELECTION: Two prize winners will be selected in a random drawing conducted on or about each day of the Sweepstakes Period from among all eligible entries received. Drawing will be conducted by Sponsor at the Sponsor address. If a prize is refused, a prize notification is returned or deemed undeliverable, or the potential winner is disqualified for any reason, an alternate winner will be selected via a random drawing. Except where prohibited by law, acceptance of the prize constitutes permission for Sponsor to use winner's name, hometown, likeness, statements, and other personally identifiable information for promotional, advertising and marketing purposes in any media throughout the world without additional prize, incentive, consideration, consent or review. The odds of winning depend upon the number of eligible Entries received during the Sweepstakes Period.

Each prize winner will receive a \$100 gift certificate to one of the locally owned businesses that was featured as a business of the day.

Failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. If for any reason the Sweepstakes is not capable of being executed as planned, or infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of Entrants, technical failures or any other causes which in the opinion of Sponsor, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right at its sole discretion to disqualify any suspect Entry or Entrant and/or to cancel, terminate, modify or suspend the Sweepstakes. In the event of any cancellation, termination or suspension, notice thereof will be posted at www.njng.com. If the Sponsor decides to reconvene the Sweepstakes after a suspension, the determination of the prize winner will be made from among all eligible, non-suspect Entries received as of the date of the suspension, as Sponsor determines in its sole discretion. Entries not complying with all rules are subject to disqualification.

DISPUTES: Entrants agree that (a) any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of New Jersey; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes but in no event attorneys' fees; and (c) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to, claim punitive, incidental and consequential damages and any other damages, other than out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, Entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the

State of New Jersey, without giving effect to any choice of law or conflict of law rules (whether of New Jersey or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than those of the State of New Jersey.
